RE : Teamsters Canada Rail Conference 2010 Convention

Further to my letter of January 6, 2010 announcing the TCRC convention, September 21 to 23, 2010 at the Crowne Plaza Chateau Lacombe Hotel in Edmonton, Alberta, this is a follow up reminder to Divisions wanting to submit resolutions to the convention.

As included in my previous letter, Divisions submitting resolutions for proposed changes to the TCRC Bylaws must follow the requirements of TCRC Bylaws, Bylaws Section 34, as follows :

Section 34 Resolutions to the Rail Conference - When Presented

Except in case of the suspension of the rules by two-thirds (2/3) vote of all delegates present, six (6) copies of any resolution that has for its purpose the changing of existing laws, or the enactment of new laws, shall be forwarded to the Rail Conference Office not less than one hundred twenty (120) days before the convention convenes and shall be mailed to the delegates not less than forty-five (45) days prior to the convention. Should the resolution recommend changes in more than one (1) section of the law, each section shall be printed on a separate sheet of paper. Each sheet shall bear a heading showing the particular section and page that is to be amended. All recommended changes shall be shown in boldface type; and the section, as it would read after being so changed or amended, shall be written out in full. Resolutions received that are not in conformity with the above will not be entertained by the Committee on Bylaws.

Consistent with these requirements, the deadline for resolutions to be received in the Rail Conference National Office in Ottawa is May 24, 2010. All properly presented resolutions will be mailed by the Rail Conference Office to delegates no later than August 7, 2010. A sample resolution form is attached to this letter for your reference.

After the few outstanding Divisions report on their Division elections and the office finalizes a few issues for the TCRC Convention then information, including Delegate Credentials, will be distributed which I expect to happen within the next few weeks.
